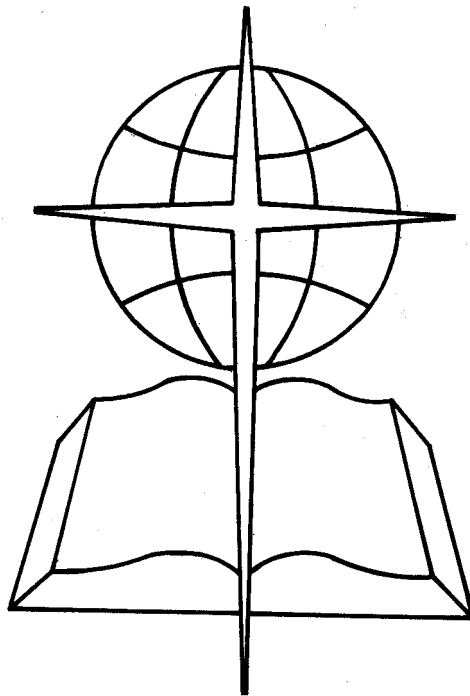

Summary

Main Entry: Southern Baptist Convention Executive Committee Records

Date Span: 1917 – 1989

Abstract: The Executive Committee of the Southern Baptist Convention is the fiduciary, the fiscal, and the executive agency of the Convention in all its affairs not specifically committed to some other board or agency. The Convention created the Executive Committee in 1917 and expanded its role and membership in 1927. Headquarters for the Executive Committee are located in Nashville, Tennessee.

The files document the actions and programs of the Committee and much of denominational life and include committee files, files on Baptist state conventions, convention agencies, other Baptist organizations, agreements and contracts, budget information, correspondence of administrators and program leaders, studies and reports, subject files, Inter – Agency Council material, committee and subcommittee minutes, and meeting files.

Historical Sketch

The Executive Committee of the Southern Baptist Convention is the “fiduciary, the fiscal, and the executive agency of the Convention in all its affairs not specifically committed to some other board or agency.” It acts for the Convention between sessions and consists of the president and recording secretary of the Convention, the president of the Woman’s Missionary Union, and one member from each cooperating state of the Convention. Additional members may be added from each state, up to a total of five, depending on church membership.

In 1916, M. H. Wolfe of Texas proposed to amend the SBC Constitution “to create one strong executive board which shall direct all of the work and enterprises fostered and promoted by this Convention.” The report of the committee dealing with the matter was presented to the SBC in 1917 and urged that a “standing committee” be established to act for the SBC between sessions. This committee of seven would represent different parts of the Convention territory. It would arrange the annual meetings and was “empowered to

act in an advisory way in all questions submitted to it on matters arising between the boards of this Convention.”

The following men were on the first executive committee: Manson Horatio Wolfe, Texas; Livingston Johnson, North Carolina; George E. Hays, Kentucky; Joseph Cole Stalcup, Oklahoma; Zechariah Thornton Cody, South Carolina; Edwin Charles Dargan, Georgia; and S. M. Brown, Missouri.

In 1927, the Executive Committee assumed responsibility for developing the SBC financial program and providing for closer cooperation between state conventions and the SBC. The Convention felt the need for an agency to be “in close touch with the Convention and its agencies.” They voted to enlarge the functions of the Executive Committee to accomplish these purposes, and Nashville became the headquarters for the Executive Committee. Austin Crouch was the first executive secretary of this expanded Executive Committee, serving until 1946. Duke K. McCall succeeded Crouch, remaining until 1951, when he became president of Southern Baptist Theological Seminary. Porter Routh was executive secretary from 1951 – 1979, and Harold Bennett served from 1979 – 1992. Morris Chapman became executive secretary in 1992.

The Executive Committee handles all Convention funds. Cooperative Program funds are distributed to agencies, boards, and institutions according to percentages adopted by the Convention. From 1933 to 1959, when the Stewardship Commission was formed, the Executive Committee was responsible for promotion of the Cooperative Program. Since the 1970s, the Executive Committee has operated with three subcommittees: Administrative and Convention Arrangements, Business and Finance, and Program and Budget. The Executive Committee studies the work of SBC boards, agencies, and institutions, and though it has no authority over them, it may make recommendations to them.

The Executive Committee promotes the work of the Convention and its agencies. One way is through its publications program. Publications of the Executive Committee have included the Baptist Bulletin Service, which began in 1945, and the Baptist Program, originating in 1925, which was distributed free of charge to all SBC pastors, state workers, and other denominational agents. Baptist Press (started in 1946), a daily news service, distributes information to Baptist state papers and the secular press. The Executive Committee is also responsible for printing and distributing the SBC Annual.

Scope and Content Note

The Administrative and Program Planning files are one series within the records of the Executive Committee of the Southern Baptist Convention. These records and files document the administrative and program coordinating responsibilities of the Executive Committee. The records are primarily those of the President (Executive Secretary – Treasurer) and the Executive vice – president (Program Planning Secretary) of the Executive Committee. The records include the files of Duke McCall, Porter Routh, Albert McClellan, and some files of Harold Bennett.

The records span the years from 1917 to 1990, with the bulk of the records dating from the 1940s to 1980. The series currently includes approximately 125 linear ft. of material.

Significant rearrangement of the files has been made, and, in most cases, the original folder titles have been retained. The files are arranged in alphabetical order by folder title.

The records include information on all aspects of denominational life from the 1940s to 1980. They include committee files, files on state conventions, agencies, and other Baptist organizations, agreements and contracts, budget information, charters of agencies, data on allocation of funds, correspondence of Routh and McClellan, studies, reports, subject files, minutes of the Executive Committee and its subcommittees, and Southern Baptist Convention meeting files.

Copies of some files from 1941 to 1966 are located on twelve negative microfilm reels of MF 2102.
