Summary

Main Entry: Southern Baptist Convention. Home Mission Board. Oral History Collection.

Date Span: 1970 – 1996

Abstract: Includes typescripts and audio recordings of oral history interviews of former Home Mission Board executives, personnel, and missionaries. Interviewees discuss missions and evangelism activities of the Home Mission Board including general Board operations, work with National Baptists, Jewish work, Christian social ministries, and city missions. Collection is divided into three series: subject files, cassette recordings, and reel to reel recordings.

Historical Sketch

The Home Mission Board (now North American Mission Board) is one of the oldest organizations of the Southern Baptist Convention. Since the Southern Baptist Convention's founding in 1845, the Home Mission Board (HMB) has trained and employed missionaries for various areas of service across North America.

First located in Marion, Alabama, the HMB relocated to Atlanta, Georgia, in 1882. In 1995, HMB staff moved to a new five-story office complex twenty-two miles north of Atlanta. In 1997, the Home Mission Board merged with the Brotherhood Commission and Radio and Television Commission to form the North American Mission Board.

Beginning in 1970, the Home Mission Board conducted oral history interviews with retiring HMB personnel and missionaries. In the 1970s and 1980s, many of the interviews were conducted by Mary D. Cannon. HMB librarian Julie Belfield conducted interviews in the 1990s. In producing the oral history interviews, staff collected biographical information, interview consent forms, and research notes on interviewees. In the 1990s, the oral history program expanded to include the transcription of interviews, beginning mainly with those conducted in the 1970s.

Scope and Content Note

The Home Mission Board Oral History Collection (5 linear ft.) consists of typescripts and recordings of over 100 oral history interviews. The interviews cover a wide variety of mission

activities including work with National Baptists, Jewish work, evangelism, Christian social ministries, and city missions. Interviews of HMB executive directors Courts Redford and Arthur Rutledge and of J. B. Lawrence's widow are also included.

Files of transcribed oral history interviews in the collection include the recorded interview transcription, consent form, biographical information, and the interviewer's research notes. For some interviews, only interviewee consent forms or biographical files are available, and are filed separately. Effort was made to determine the date of each recording. In instances where no date was provided on the audio recording, no date is listed in the inventory.

Arrangement

The collection is divided into three series: subject files, cassette recordings, and reel to reel recordings. Items in each series are arranged in alphabetical order by folder or recording title.
