## **Summary**

Main Entry: Annuity Board Records

Date Span: 1918 – 1984

Abstract: The Annuity Board of the Southern Baptist Convention was established for Southern Baptist pastors' and their widows' economic security in their old age. It was later broadened to include retirement, health insurance, and life insurance needs of Southern Baptist Board employees.

#### **Historical Sketch**

The Relief and Annuity Board was established in 1918 for the purpose of making provision for the economic security of Southern Baptist pastors and their widows in old age. Later, eleven new plans to meet retirement needs of employees of Southern Baptist Boards, hospitals, schools, and orphanages were added. William Lunsford was instrumental in the creation of the Relief and Annuity Board and served as its first executive director. Lunsford was succeeded by Thomas Watts, who held the post for eighteen years. In 1947, Walter R. Alexander became executive director. The director files of these three leaders are included in the collection. In 1955, R. Alton Reed became executive secretary, and a new building was occupied in 1959. In 1960, the Convention authorized the change in name to Annuity Board. The Board programs and plans expanded to meet the retirement, health insurance, and life insurance needs of pastors and denominational employees. In 2004 the Annuity Board charged it name to GuideStone Financial Resources to reflect its expanded services.
