Abstract: The official papers and records of the Executive Office of the Sunday School Board of the Southern Baptist Convention. Includes internal files related to the work and management of the Sunday School Board primarily for the administrations of Grady Cothen and Lloyd Elder. The records also include informational files and correspondence with other SBC agencies and religious organizations. Issues and controversies within the Convention are the focus of some material in the collection.

Biographical Note:

Cothen, Grady Coulter, 1920-2017

Grady Cothen was born August 2, 1920 in Poplarville, Mississippi. Cothen was a pastor, Baptist state convention executive, university president, seminary president, and president of the Sunday School Board of the Southern Baptist Convention from 1975-1984. He served as pastor to churches in Tennessee, Oklahoma, and Alabama. He was the Executive Secretary of the Southern Baptist General Convention of California, 1961-1966, president of Oklahoma Baptist University, 1970-1974. He was a graduate of Mississippi College and New Orleans Baptist Theological Seminary. He held honorary doctorates from six Baptist educational institutions. He published several books including: *Faith and higher education*, 1976; *Unto all the world: bold mission*, 1979; *What happened to the SBC?: a personal memoir of the controversy*, 1993; *New Southern Baptist Convention: a moderate look at fundamentalism*, 1995; and *Soul Freedom*, 2000. He retired as president of the Sunday School Board in 1984 and was succeeded by Lloyd Elder. He died in Ridgeland Mississippi on May 19, 2017 at the age of ninety-six.

Elder, Lloyd, 1933-

Lloyd Elder was born in Dallas, Texas on May 8, 1933. He attended Decatur Bible College, Howard Payne University and Southwestern Baptist Theological Seminary where he received his Masters of Divinity degree and Doctor of Ministry degree. He served as pastor to four churches in Texas, including the First Baptist Church, College Station, 1965-1969 and Gambrell Street Baptist Church, 1969-1975. He was

Assistant to the Executive Director of the Baptist General Convention of Texas, 1975-1978 and then Executive Vice-President at Southwestern Baptist Theological Seminary in Ft. Worth, Texas, 1978-1983. He was elected as president of the Sunday School Board of the Southern Baptist Convention in 1983 and served until his forced retirement in 1991. After leaving his position at the Board, he became professor at Belmont University and Chair of Biblical Studies and Preaching. In 1996 he was named Director of the Moench Center at Belmont University. The center was established to provide leadership skills for ministers. He retired from that position in 2004. Elder has authored several books and pamphlets including: *Taking charge of your time & stress: proven skills, for life, leadership, and ministry*, 2013; *Calling the family back together: a research report to the Southern Baptist family*, 1993; *Blueprints*, 1984.

Scope and Content Note: The official papers and records of the Executive Office of the Sunday School Board of the Southern Baptist Convention. Includes internal files related to the work and management of the Sunday School Board primarily for the administrations of Grady Cothen and Lloyd Elder. The records also include informational files and correspondence with other SBC agencies and religious organizations. The records contain division and departmental files of the Sunday School Board, annual reports, financial data and audits, internal and external correspondence, complaints and suggestions from users of Sunday School products and services. Documents on legal matters, communications with state conventions and trustees are a major part of the record group. Files related to most SBC agencies and other organizations are part of the collection. These includes files on the six SBC seminaries, American Bible Society, Baptist Joint Committee on Public Affairs, Baptist Spanish Publishing House, Baptist Faith and Message Fellowship, Baptist World Alliance, Brotherhood Commission, Christian Life Commission, Education Commission, Foreign Mission Board, Historical Commission, Home Mission Board, Inter-Agency Council, North American Baptist Fellowship, Radio and Television Commission, SBC Executive Committee, and Stewardship Commission. Information and files related to Glorieta and Ridgecrest Conference centers are included in the records. The collection does include some correspondence related to Jimmy Draper, who succeeded Lloyd Elder as president of the Sunday School Board.
